## People and organisations to be notified after someone has died



The following checklist and attached template letter are aimed at assisting with the process of notifying the relevant organisations in the event of a death.

The **Australian Death Notification Service** is a free government initiative to help people get in touch with multiple organisations using a single <u>online</u> notification. Participating organisations include banks, superannuation funds, utility providers, insurance companies, government, education and other services providers. A death certificate needs to have been registered with Births, Deaths and Marriages. This service only works when it can match the details provided to the record.
